

2012 INTERNATIONAL SWIMMING POOL AND SPA CODE

TOWNSHIP OF BAINBRIDGE

BERRIEN COUNTY, MICHIGAN

Ordinance No. 38 A

An ordinance establishing the minimum regulations governing the conditions and maintenance of all residential, property, buildings, swimming pools, spas and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use and the demolition of such structures; known as the Building Code.

Hereby ordained by the Township Board of Trustees of Bainbridge Township, Berrien County, Michigan as follows:

SECTION I

Pursuant to the provisions of the 2012 International Swimming Pool and Spa Code, the Township of Bainbridge hereby adopts and incorporates by reference any and all amendments to the 2012 International Swimming Pool and Spa Code, including any and all future amendments to said 2012 International Swimming Pool and Spa Code, the same being adopted hereby by reference to said amendments.

SECTION II

That all other ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION III

That nothing in this ordinance or in the 2012 International Swimming Pool and Spa Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

SECTION IV

That the Bainbridge Township Clerk shall certify to the adoption of this ordinance, and cause the same to be published one time in a newspaper of general circulation; and this ordinance shall take effect and be in force from 30 days after publication.

At a meeting of the Township Board for Bainbridge Township, Berrien County, Michigan, held on the 9th day of May, 2016 it was moved by J. Jollay and supported by D Biaers that the 2012 International Swimming Pool and Spa Code, as amended, is hereby adopted as the International Swimming Pool and Spa Code for Bainbridge Township, effective upon publication one time in a newspaper of general circulation in Bainbridge Township.
